#### Data Files

There are 451,075 records for 2010. More information on participation is available in the <u>States Conducting</u> <u>Surveillance by Year</u> table. The data files are provided in ASCII and SAS Transport formats. The May 25<sup>th</sup> update corrected one variable on five records in the Colorectal Cancer Screening section. The August 18th update corrects an issue with \_FINALWT for AZ and DC.
